



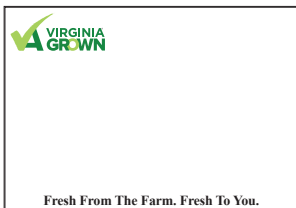
# Virginia Grown Point-of-Sale Items
